#### **Every year in Australia:**

4,186+ people die from alcohol-related injuries, illness and accidents<sup>1</sup>

75,511 people are hospitalised due to alcohol²

2,227 people die from drug-induced deaths³

More people die from <u>drug overdoses</u>, including from pharmaceuticals, than die on the roads<sup>3</sup>



- Reducing risk factors such as poor mental health, unemployment and disengagement




# How we work

Programs that **reduce harm** from alcohol and other drugs and reduce the burden to society, e.g.:


- providing resources for more informed decision-making



- Your club is prepared if there's an incident



#### **Activities**

- Design and develop a HFTG program partnership with the
   provider and other key stakeholders. Topics could include
  - sports betting in SA,
  - links between gambling exposure and risk of harm
  - creating healthy and safe sporting environments
  - how to talk to young people about gambling

#### **Short term outcomes**

- Participants better understand the risks of sports betting and tactics used by the gambling industry

# Pilot project - deliverables



#### **Deliverables**

1. Design the pilot project in line with public health framework

Procure an appropriate academic partner

Design process and short/medium-term outcome measures

- 2. Co-design and create the Here for the Game educational content
- 3. Validate HFTG questions, actions, policy and education strategies
- 4. Develop the appropriate system functions and supports in Salesforce
- 5. HFTG pilot implementation

Recruit 50 (TBC) sporting clubs per year

6. Evaluation
